Please allow 2-3 weeks for the application to be reviewed.

Due to the magnitude and complexity of some projects; Interlink does not presently wish to facilitate land purchases or large institutional construction. We would encourage anyone seeking a project of that nature to form their own 501 (c)(3) or look to another organization equipped to handle the ongoing special details and requirements.

Coordinator Qualifications

Project Coordinator must be a United States (US) resident
